Charge(s):	(1) Mr Finn presented the greyhound 'Tiggerlong Al' (" <b>Greyhound</b> ") for the purposes of competing in race 7 at the Wagga Wagga meeting on 1 October 2021 in circumstances where the Greyhound was not free of any prohibited substance;				
Prohibited Substance(s):	Cobalt above the mass concentration limit of 100 nanograms per millilitre				
Disciplinary action taken:	9-week suspension				

## Charge

Following receipt of a certificate of analysis from Racing Analytical Services Limited dated 5 November 2021, the Commission commenced an investigation into the results of a post-race urine sample taken from the greyhound, 'Tiggerlong Al' ("**Greyhound**") at the Wagga Wagga meeting on 1 October 2021.

Further analysis of the sample was conducted by the Racing Chemistry Laboratory, confirming the presence of cobalt above 100ng/ml in the sample.

## Evidence, plea and submissions

On 11 February 2022 Mr Finn was issued with a notice of proposed disciplinary action ("**Notice**") in relation to the charge, setting out the proposed disciplinary action to be taken and the grounds in support of that proposed disciplinary action. Mr Finn was also provided with a brief of evidence.

On 24 February 2022 Mr Finn attended the scheduled hearing with the decision makers and entered a plea of guilty and made submissions.

The decision makers considered Mr Finn's plea and submissions and issue the following decision.

## **DECISION:**

- 1. Mr Finn is a registered greyhound trainer and the trainer of the Greyhound. The Greyhound competed in race 7 of the Wagga Wagga meeting on 1 October 2021. Following the Event, a urine sample was taken from the Greyhound.
- 2. The post-Event swab revealed the presence of cobalt above the threshold. Cobalt above a mass concentration of 100ng/ml is a prohibited substance under Rule 83(10) of the Rules.
- 3. The decision makers charged Mr Finn with the offence under Rule 83(2)(a), which reads:
  - (2) The owner, trainer or person in charge of a greyhound-
    - (a) nominated to compete in an Event;

shall present the greyhound free of any prohibited substance.

4. The decision makers found the charge proven and took the following disciplinary action against Mr Finn

- 5. In taking this disciplinary action, the decision makers considered all evidence, including:
  - Greyhound racing penalty precedents in NSW;
  - The length of time Mr Finn has held a trainer registration, being since 1993, a period of approximately 29 years;
  - Mr Finn's disciplinary history noting his lack of any conduct or substance breaches in his long-held association with the greyhound industry;
  - Mr Finn's submissions in mitigation of penalty, including his review of and amendment to his animal husbandry practices; and
  - Mr Finn's plea of guilty at the earliest opportunity.
- 6. Mr Finn's penalty was deferred in accordance with Rule 95(5) of the Rules, with the suspension period to commence on 26 February 2022.
- 7. In addition, the Greyhound was disqualified from race 7 at the Wagga Wagga meeting on 1 October 2021 pursuant to Rule 83(4) of the Rules.
