This form is to be used when a participant who is under investigation or disciplinary action, would like to transfer ownership and/or trainership of a greyhound.

Local Rule 155a restricts owners and trainers who have a positive analysis and Local Rule LR178C restricts defaulters and persons who are disqualified, suspended, or warned off from transferring greyhounds.

A participant must seek approval from the Commission and provide exceptional circumstances to transfer any greyhounds from their custody.
