6. Protocol updates and Rule changes

- The Chair verbally updated the committee as to the protocol updates and upcoming rule changes
- CEO confirmed the new pin firing is a NSW rule as it is banned under POCTA
- CEO confirmed an interstate dog that had been pin-fired would not be eligible to race in NSW

7. Other Business

- CEO noted the following:
 - Persons charged on the GWIC website will no longer be visible
 - Penalty guidelines will be issued and published from next week so it is visible to the industry and applies consistency
 - The move to the Hub model – localised where issues can be dealt with as quickly as possible
 - The publication of the new Fit and Proper Person Framework regarding registration / re-registration <https://www.gwic.nsw.gov.au/registration/registration>
 - New Inspection protocols have also been established and will be published on the GWIC website – to focus on inspections in a responsive manner to complaints and issues, or requests
 - With GWIC being part of government, the advantage is complaints can be made to the NSW Ombudsman and ICAC, as they provide an oversight on government bodies
- Barry Ward noted the draft breeder incentives will be circulated soon for stakeholder engagement

 - previously suggested that the notice should show where the service took place as well as was it AI, natural etc.
 - GRV has a good model. The only thing Jenny didn't agree was publishing the breeders phone numbers.
