

GREYHOUND WELFARE & INTEGRITY COMMISSION DISCIPLINARY ACTION DECISION

Date of decision: Friday 24 November 2023

Charge(s): Charge - 156(f)

Mr. Cauchi did a thing which, in the opinion of the Controlling Body, constitutes an offence by engaging in an activity which

constitutes misconduct

Plea: Not Guilty

Disciplinary action taken: To issue a \$1000 fine and 3-month suspension, wholly and

conditionally suspended for a period of 12 months subject to Mr. Cauchi not breaching this or any like rule in this period.

DECISION:

- 1. Mr Cauchi was, at all relevant times, a registered Attendant with the Greyhound Welfare and Integrity Commission.
- 2. On Tuesday 3 October 2023, Mr. Cauchi attended the Gosford Greyhound Club.
- 3. During the course of the meeting Mr. Cauchi became involved in a physical altercation with another participant in the bar area of the club, resulting in an affray which required the intervention of bystanders to deescalate.
- 4. On 15 November 2023 Mr Cauchi was issued with a notice of charge and proposed disciplinary action ("**Notice**"). The Notice issued a charge against him for breach of the following Greyhound Racing Rule:

Charge - Rule 156(f), Rules

An offence is committed if a person (including an official):

- f) has, in relation to a greyhound or greyhound racing done something, or omitted to do something, which in the opinion of a controlling body or stewards:
 - (ii) constitutes misconduct or is negligent or improper
- 5. The Notice invited Mr Cauchi to attend a hearing on Wednesday 22 November 2023 and to enter a plea and make submissions in relation to the charge.
- 6. At the hearing conducted on Wednesday 22 November 2023 Mr Cauchi;
 - Entered a plea of not guilty; and
 - Made verbal submissions.
- 7. Following considering of Mr Cauchi's plea and verbal submissions, the decision-makers found the charge proven and took the following disciplinary action against him:
- Charge To issue a \$1000 fine and 3-month suspension, wholly and conditionally suspended for a period of 12 months subject to Mr. Cauchi not breaching this or any like rule in this period.
- 8. In taking this disciplinary action, the decision-makers considered all evidence, including:
 - Mr. Cauchi's Not Guilty plea
 - Mr. Cauchi's 45-year history in the industry and good record, with no previous charges over any similar matter
 - Personal and professional circumstances, and Mr. Cauchi's contrition and remorse for his conduct
 - Purpose of issuing penalties as a protective measure for the image and interests of the greyhound racing industry
 - Principles of specific and general deterrence and what message is sent to the industry in respect to such conduct.
