## HOW TO....

### Apply for an internal review

You can apply for an internal review if you disagree with a GWIC decision made against you. A new decision-maker will be allocated to review the matter and determine whether the original decision should be confirmed, varied or revoked.

To apply for an internal review you need to submit an Application for Internal Review form along with a copy of the Notice of Decision and any supporting documents to <a href="mailto:internal.review@gwic.nsw.gov.au">internal.review@gwic.nsw.gov.au</a> or PO Box 718 Bathurst NSW 2795. Applications must be submitted within 28 days of the original decision.

# PIN-FIRING IS PROHIBITED

Pin-firing is illegal in NSW. It is prohibited under the Greyhound Racing Rules and POCTAA.

There is no evidence to support the practice of pin-firing. If pin-firing is identified disciplinary action will be taken and any greyhounds found to have undergone the procedure at any stage, will not be permitted to race.

involved before they can apply for an Associate Attendant registration at age 14 Permit holders must be supervised by a registered adult participant.

#### **Code of Practice - Barriers**

The Greyhound Welfare Code of Practice requires greyhounds to be securely confined to prevent their escape from the property, with two barriers between a greyhound and escape from the property, unless they are under supervision.

Supervision means there must be someone present with greyhounds who could intervene immediately if required.

Owners and Trainers are reminded that it is an offence to give ANY treatment to a greyhound on the day it is racing (See Racing Rule 145(4)). This includes all prescribed medications or any medications from pharmacies. Any type of tablet, capsule, pill, syringed liquid or paste must not be given.

Also, injectable substances of any kind cannot be administered earlier than an entire day prior to the midnight before a greyhound races.
